Memo regarding closure of the NPASCNA PNC Bank account

Prepared by Ally L., vice treasurer

Prepared on: 3/4/2022; presented on 3/26/2022; finalized 3/28/2022

On March 3rd, the treasurer logged into the NPASNA PNC bank account and saw a fraudulent \$0.01 *credit* from Etsy. This indicated that our account information had been added to an Etsy profile. Since our account information is not, and should not, be used anywhere, Ally contacted the Area Chair, Valorie L. Valorie L. is named on the account and would have to facilitate any communications with PNC bank.

Through a series of phone calls, it was determined that the next step was to go to PNC bank on Friday, March 4th and discuss appropriate actions, including potentially closing the account. It was after 5pm when the charge was identified, so there was nothing that could be done that day.

We (Ally and Valorie L.) asked about putting a hold on the account, however, a hold takes 24 hours to kick-in so per PNC there was no reason to do that in advance of going to the bank the next day (at which time we could either place a hold or close the account). We reached out to the various individuals with outstanding checks (see list on following page) and notified them not to cash these checks until further guidance was provided. No stop payment requests were necessary since the account was later closed. New checks will be issued at the March ASC meeting.

On March 4th, Valorie L. met with PNC Bank. Because there was an issue of fraud, it was required by PNC that the account be closed (this is why it was not delayed until March ASC for discussion). Maintenance of the current structure – i.e. only the treasurer can access the account online but is not named on the account/can't access it even if they call, no debit/credit cards, etc., was observed. Checks were ordered along with a new deposit stamp (reflected in March ASC expenses). Discussions were had regarding potential safe-guards that we can have in place to protect ourselves moving forward. See new business for this motion.

In addition, when speaking with PNC Bank they were able to tell us the name associated with the fraudulent Etsy account and it was Valerie B., the activities subcommittee chair. She has been having ongoing issues with her identity being compromised. She shut down her personal PNC account, from which we believe our account issue was taken when she deposited one of our checks immediately preceding the incident. She reported the issue to PNC.

Overall net cost to area for this issue - \$80.68 which reflects cost of new checks and deposit stamp.

Trusted servants were also asked to properly dispose of checks if/when using mobile deposit. That was not the issue here, but is good practice to maintain security of our account information.

UPDATE 3/4/2022

Upon speaking with PNC regarding the fraud issues, they indicated that the stop payment request mentioned below did not appear in the system. Therefore in March 2022's ASC, we will see a "credit" reflecting the \$33 stop payment fee originally included in February's expenses. Since the account was closed, no stop payment fee was re-entered.

At September's Area service meeting, a check (#1746) was written for the area service literature purchase at the Regional Office. It was sent to Region along with our donation check. The donation check was cashed, however, this invoice payment was not. Regional deposits are often a month behind, so we gave them until November/early December before we followed up. With limited personnel at the Regional Office, we provided them additional time to look into the matter prior to cancelling the check.

Ally L, vice treasurer, was notified after January's area service that the regional office had don't their due diligence in looking for the check and that a new check should be written. She waited until February's area service and requested PNC cancel the check and a new check (#1769) was written for the invoice. It was mailed to the regional office 2/28/2022.
