Motion is outlined below.

<u>New Motion</u> presented by P&A Chairperson on 2/16/19, To Keep the \$2500.00 check from Visiterie.com from the Start to Live Convention.

Intent: to deposit back into funds for Start to Live Convention

NPASCNA requested the email provided by check writers as to the intent of the provided monies. Waiting on the email from TSRSCNA

Additional details from discussion:

"Visiterie.com" is how we book the STL convention. This check represents an 'incentive' they provide to <u>all of their customers</u> to encourage you to book with them again in the future. They provide this monies regardless of whether or not we're NA or some other entity. The question is, is it acceptable for NA to receive this money and keep it.

Jim, BOD Representative, noted that the BOD voted to accept the funds but with the increase in questions about whether or not it was fair or a tradition violation, let them to turn this matter over to the homegroups. The question was asked regarding what would happen to the money if we did not accept it – it would be 'returned' to Visiterie (we have not cashed the check, so it would be voided).

Ally, Secretary, reminded everyone that the motion(s) are listed under Area Service Resources, Area Documents. In addition to being in the email with the minutes, the motion(s) are posted there for you to review with your homegroup.

P&A Subcommittee – Chair position is vacant, no report was provided. Russel did indicate that we would like to, as an Area, continue to review and modify policies as we had been doing. Those meetings will continue and you will be notified when they occur (all are welcome).

Activities Subcommittee – Chuck P provided a report. (pg 10) He emphasized that all proceeds from the upcoming comedy show go towards the Summer picnic. The funds they are collecting are in order to provide additional activities at the Area level and to show addicts that you can have fun in recovery. Ally, Secretary, clarified/reiterated that although the Activities subcommittee's balance at the start of the Area's "fiscal year" is \$450, all funds collected remain in their reserve and are not reallocated to the Area in any manner, even if at the close of the fiscal year their account holds more than \$450.

Website – Chair position vacant. As secretary, it is Ally's responsibility to fulfill this role. The website is being updated, however, there has been limited movement on the new website (which the group approved during the January Area Service Meeting). Ally has not had time but will be convening the ad hoc committee to work on that and once the website is drafted, they will bring forth questions to area for voting, as needed. It was reiterated that the chair of the website does not need to have any website experience and that the goal of this

new website is that it's intuitive and meant for someone that does not "do websites".

Start to Live Programming Liaison – position is vacant, no report was provided.

Literature Report – Natalie provided the literature report (pg 11)

Treasurer Report – Gina provided the treasurer report (pg 12-13). We will continue to provide the bank statements (pg 14-15) in the monthly minutes for transparency.

The sharing session was waived by the group.

There was one motion in old business for voting (pg 16). Voting GSRs were recounted – 21. The motion passed.

In new business, a motion was drafted to donate the amount above prudent reserve to Region. The motion passed (pg 17).

Russel reviewed the upcoming area service meetings – March 30^{th} and April 27^{th} . It was noted that May's Area Service (which would fall on the 25^{th}) overlapped with Memorial Day and the Spiritual Retreat. The day is adjusted to June 1^{st} (no voting is required).

Region met February 16, 2018 at the TSRSO. There were 11 out of 21 areas in attendance. 
