#### New Business:

- A. <u>Start to Live Packages of Hope</u>
  - a. 23 packages of hope were received by North Pittsburgh Area. Fourteen (14) were distributed to present GSRs at the last Area Service. The remaining nine (9) packages of hope were provided to the present GSRs.
  - b. Because there were more than nine homegroups represented, the homegroup names were put in a box and drawn by Julie B and announced by Ally L.
  - c. The following home groups received a package: Hopeful Horizons, Bellevue Beginners, Sunday Surrender, NA Way, Atmosphere of Recovery, Text Messages, Growing Stronger, Real Deal, and Staying Clean for Dummies.
- B. Carl F. brought forth a motion (paraphrased) to implement vice chair positions for all those positions which do not have one noted in NPASCNA policy. The intent was to get more individuals involved and create learning positions. The motion was seconded, which opened it up for discussion. Ultimately, Carl withdrew the motion prior to voting. Discussion below.
  - a. Ally L. Subcommittees H&I, P&A, PI, and Activities each have their own set of positions including vice chair, secretary, etc. Those positions are voted on at the subcommittee level whereas trusted servants such as Treasurer, Literature Coordinators, etc. are voted on at the Area level.
  - b. Carl F. asked about who elects these individuals within the subcommittee. Ally L. noted that within each subcommittee policy, there are requirements that must be met to be considered a voting member of that subcommittee including, in general, attendance of a certain quantity of meetings in tandem.
- C. Ally reviewed, on behalf of P&A, the proposed changes to NPASCNA policy, reflected in <u>motions 1-9</u>, all of which need **voted on at the homegroups**. Copies of the motions were made available to the GSRs and will be online as well.
  - a. The proposed motions are in the same NPASCNA draft aforementioned in old business.
  - b. When possible, the motion was denoted in the left margin of the document to call attention to it.
  - c. Use of individual motions allow the group to vote on each change individually in lieu of approving/denying the entire document.
  - d. All motions need seconded by a GSR. Motions were read allowed first, then seconded, then clarified if necessary. Ally L informed GSRs that the seconded motions would be online, so they should assure their homegroups that although their copies did not include a seconded signature, they were seconded.

Following discussion of the motions, the literature and treasurer report were done.






